Dear Friends of Horizons,

The last year has been a monumental one for the families we serve as they continue to adapt to the realities and challenges that Covid-19 presents. It has also been a monumental year for Horizons as an organization as we moved our operations into the new Edgerley Family Horizons Center in April 2021.

The new center has allowed us to serve 30% more children and families experiencing homelessness. This dynamic learning environment brings together our teaching teams from our three sites, enhancing standards and allowing more teaching collaboration across all our classrooms. The new center allows for expanded curriculum in STEM and literacy, as well as space for gross motor development and play. Our Family Advocates continue their work to identify and address the critical needs of parents, helping them find their strengths and the resources to build upon them. More than 150 families enrolled this past year in Mobility Mentoring®, working toward financial independence, stable housing, and sustainable career goals. At the same time, our Playspace team continues to adjust to changes brought on by the pandemic with workshops and programming for parents, recognizing their wellbeing is the single most important determinant in their child's success.

Horizons' financial position remains strong, thanks to sustained state and federal funding as well as our generous community of philanthropic supporters. Many individual and corporate partners saw the needs of families in the height of the pandemic and responded to help us address those needs. This spring, Horizons Board of Directors approved a bold new compensation model for our frontline workers to address longstanding inequities in the compensation for early educators. Already we are seeing the profoundly positive impact this change is having on the wellbeing of our workforce. We view this as another step in Horizons' continued pursuit of building a more inclusive and equitable world.

There was much to celebrate in this past year despite the ongoing pandemic-related challenges. The word 'resilience' – that of our families, staff and community of supporters has never meant more. On behalf of the leadership team, thank you for working alongside us to make a better future possible for the children and families we have the privilege to serve.

PROGRAM HIGHLIGHTS

Over the past fiscal year, Horizons made great strides in our work. Here are just a few highlights:



Early Education Center

We continued our work on behalf of children experiencing homelessness in Boston by offering free, high quality, traumasensitive early education in our new center and headquarters, the Edgerley Family Horizons Center. All three of our early education centers moved into this central hub for comprehensive childcare.

Family Partnerships Program



We partnered with Horizons' parents by using a strengthsbased focus to support and empower them as they build skills and strategically set goals for a sustainable future.

Playspace Program



We reinvigorated a robust classroom volunteer program, pivoted to offer outdoor play for children living in shelter and began offering programming directly to parents, building their play skills and knowledge while shelters were closed to volunteers.




